Minutes from the Board of Assessors Meeting which was held on January 11, 2024

Open Session Meeting called to order: at 2pm. The motion was made by Michael Leitzel and seconded by Elllen Sullivan to call the meeting to order.

The Board opened the meeting by the reviewing a fiscal year 2025 61A chapter land application relating parcel map 15 lot 235.
