## **DIRECTOR'S REPORT: Debi Oliviere-Llanes**

- Deb attended various meetings and trainings.
- Deb spoke with Krissanne (Recreation Director), Sean Feeney (Facilities Director) and the trustees regarding maintenance issues in the Community Building. The issues have been brought up at the

selectmen's meetings and are being addressed. However, it will take time for these issues to be resolved.

- \$7800 grant was awarded for a Caregiver Respite Scholarship. Ten Bourne residents can receive \$780 toward an Adult Day Health Program.
- A few programs needed to be postponed due to Covid protocols, particularly those involving food and beverages.
- Independence House is offering free Domestic Abuse counseling at the COA.
- Debi and Merry are participating the Boston University Behavioral Health Cader Program. Mental health continues to be a huge issue, not only for seniors, but for everyone globally.
- AARP will be back from February through early April for tax return preparation.
- Mask wearing is now required for all COA programs.

**OTHER BUSINESS:** 

- Board members were reminded to complete the EOES training.
- MCOA is working on a manual, potentially ready in February or March, that we can use as a guideline to restructure our own manuals.
- Discussion on the Certificates of Appreciation to retired Board Members has been tabled until February meeting.
