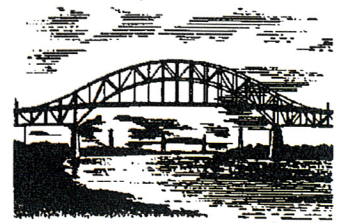

JOINT SESSION MINUTES March 16, 2021

Remote meeting was called to order at 07:11pm

- 1. Call Joint Session to order with the Bourne Board of Selectman.** Attendance was taken. Mr. Andrews, Mr. Barlow Jr., Mrs. Mastria and Mr. Uitti were present. Mr. Barlow Jr. called the Joint Board of Health Meeting to order.
- 2. Discussion and possible vote to fill Board of Health vacancy – review any/all applications including Barbara Princiotta.** Mrs. Judith Froman, Chairwoman of the Selectboard started by explaining that this joint meeting was to address a vacancy for the unexpired term within the Board of Health. The vacancy that was posted explained that those who were interested in applying for this position would be filling it until the 2021 Annual Town Election in May. There was one applicant for the position listed whose name is Barbara Princiotta, whom was present at the meeting to address both Boards. Ms. Princiotta thanked the Boards for the opportunity presented. She stated that she as a resident of Buzzards Bay she was interested and committed to fill the role that was vacant. Ms. Princiotta said that she had reviewed the materials and duties and believes that she is well organized and has the time and ability to take on the task and asked if there were any questions. Mr. George Slade asked Ms. Princiotta if she was intending to run for the seat in the upcoming town election. Ms. Princiotta replied that she did intend to run for the seat in the upcoming election. She continued by stating that she had already pulled the papers, that she was looking forward to getting to know the other Board members and learning more about what the role entails. Mr. Slade thanked Ms. Princiotta for her response. There were no other questions. Mr. Uitti stated that he had no questions but had reviewed Ms. Princiotta's resume and that it looked good to him. Mrs. Froman asked if there was a motion from the Board. Mr. Uitti made a motion to appoint Barbara Princiotta to the Board of Health until the Annual Town Election takes place. Mr. Andrews seconded the motion. Roll call vote to approve. Mr. Andrews...yes, Mrs. Mastria...yes, Mr. Uitti...yes, Mr. Barlow Jr....yes. All were in favor and the motion from the Board of Health passed unanimously. Mr. Andrews added that the Board of Health had just come from a meeting where the Board had decided the next Board of Health meeting would take place on March 31st, 2021. He asked for Ms. Princiotta to get to the town hall so that she could be sworn in prior.
- 3. Board of Health Adjourn from the Joint Meeting.** Mr. Barlow Jr made a motion to adjourn the meeting. Mr. Andrews seconded the motion. Roll call vote to adjourn. Mr. Andrews...yes, Mrs. Mastria...yes, Mr. Uitti...yes and Mr. Barlow Jr....yes. All were in favor and the joint meeting adjourned at 7:25pm.
