Chief Woodside said that the only budget account that went over budget was the utility account due to the inability of knowing that Buzzards Bay Water was going to be so high., so that line item is in the negative by about \$8,500.00. He said they are way under budget on everything else.

3.) Project Update:

- A.) Owners Project Manager Daedalus John Feeley said that they have finished flooring, started up the mechanical systems. Testing and balancing are complete. The work on the firing range is complete and they are working on the punchlist items.
- B.) Architect's Update Kaestle Boos: Mr. Mercy said that there are no RFI's, there are a few closeout submittals out. There is a substantial completion date of June 19. There are currently 6 PCO's that are being reviewed. There was discussion about what needs to be done by the substantial completion date, and what can be done once the department has moved into the building.
- C.) Wastewater project update MJ Mastrangelo said that there are two pending PCO's #76 for \$2,631.44 and #24 for \$1,841.28. She said that they need to submit these shared co to MassWorks by a deadline for reimbursement or they will lose the reimbursement. These two PCO's were included in change order #11 which was in the Pay Rec. for M. O'Connor that was just approved. Chief Woodside there is a pending shared cost for fencing, and it will be after July 1.

Peter Meier said that he has received some complaints from neighbors regarding an infestation of mice and rats and they feel it is due to the construction of the Police Station and the Wastewater Facility. Mr. Sullivan said there is no indication of rats or mice, and he does not see that what they are doing would cause any infestation of rats or mice.

- D.) Bypass access update They are waiting on final approvals.
- E.) National Guard Easement Chief Woodside said they received some fencing prices, so they are just waiting for that work to be done, most likely in July.
- **4.) Members' comments/requests:** Chair Noyes asked about the move in date. Chief Woodside said that he is not confident in the substantial completion date. July 14 is the date that everything is scheduled to get changed over.

The grand opening is on the back burner due to COVID-19.

John Redman asked for a copy of the shared cost sheet, and Mr. Sullivan said he would take care of it.

John O'Brien asked about committee members getting a tour of the Police Station, and Chief Woodside said that they can do it for 1 or 2 people at a time.
