OUTREACH: Kari Leighton presented highlights

- Kari and Merry James both attended several Zoom meetings and trainings.
- Vaccine clinics for homebound residents were very busy. Refreshments were passed out for BFD and Bourne Oaks staff members.
- 62 individuals were vaccinated at a clinic at Continental and at Roland Phinney.
- No Knox Boxes were installed.
- 3 Fuel Assistance applications and 1 Tax Abatement application were processed.
- The St. Patrick's Day drive through event handed out 135 Corned Beef & Cabbage dinners and delivered 10 meals to homebound seniors.
- 95% of Bourne residents over 75 years of age have been vaccinated.

DIRECTOR'S REPORT: Debora Oliviere-Llanes

- Cyd's Kitchen provided 194 meals to seniors last month.
- Over 200 tax returns were completed with the AARP Volunteers.

- 127 seniors were vaccinated at the senior housing clinics.
- SHINE continued to counsel seniors on health insurance options.
- Appointments were held with Elder law attorneys.
- Upcoming Events include: Synergy of Sound, Mother's Day and Father's Day drive through events, a boxed-lunch drive through event, and an Ice Cream Social at Buzzard's Bay Park.

OTHER BUSINESS:

- Progress on the reconstruction out back was shown via shared screen.
- Movies are to start up again in June, exercise classes to (hopefully) begin in July
- Affordable housing (shortages) and food distribution was discussed
