Enclosed are an original and five (5) copies each of two petitions filed by NSTAR Electric Company d/b/a Eversource Energy ("Eversource" or the "Company"):

- (1) Petition of NSTAR Electric Company d/b/a Eversource Energy for Approval to Construct and Operate a New, 115-kilovolt ("kV") Overhead Transmission Line Through Bourne, Sandwich and Barnstable, pursuant to G.L. c. 164, § 72 ("Section 72 Petition"); and
- (2) Petition of NSTAR Electric Company d/b/a Eversource Energy for Individual and Comprehensive Zoning Exemptions from the *Zoning Ordinance of the Town of Barnstable*, pursuant to G.L. c. 40A, § 3 (the "Zoning Petition").

Each Petition is in connection with the construction and operation of a new, approximately 12.5-mile, overhead 115-kV electric transmission line (the "New Line") along existing Eversource right-of-way ("ROW") between Eversource's Bourne Switching Station and West Barnstable Substation. The proposed New Line, which will travel through Bourne, Sandwich, and Barnstable, and the related station improvements comprise the proposed project (the "Mid Cape Reliability Project" or the "Project").

Also, on this date, the Company is filing with the Energy Facilities Siting Board (the "Siting Board") a petition for approval to construct, operate and maintain the Project under G.L. c. 164, § 69J (the "Section 69J Petition"), which has been docketed as EFSB 19-06. The Section 69J Petition, in combination with the Section 72 Petition and the Zoning Petition filed herewith, demonstrates that, consistent with G.L. c. 164 § 72, the Project is needed, will serve the public convenience, and is consistent with the public interest. Furthermore, consistent with G.L. c. 40A, § 3, the Project is reasonably necessary for the convenience and welfare of the public.

In order to ensure a coordinated and timely review of the interrelated petitions, the Company requests that: (1) the Chair of the Department refer to the Siting Board the Section 72 Petition and the Zoning Petition; (2) the Siting Board accept for review the Section 72 Petition and the Zoning Petition; and (3) the review of all three petitions be consolidated into one proceeding. Accordingly, enclosed is a Motion to Refer the Section 72 Petition and the Zoning Petition.

Notices of Appearance of Counsel are being filed with the Section 69J Petition. In addition to the Section 72 Petition and the Zoning Petition, the Company is providing the following herewith:¹

- Completed Section 72 Checklist and completed Checklist for Filing Zoning Exemption; and

The Company has forwarded a copy of the Petitions to the Towns of Bourne, Sandwich and Barnstable.
