- * Buzzards Bay Bank Pediment, Signage, and Main Street History Nothing New (Blanche was excused from this meeting).
- * Cape Cod Canal Highway Bridges No new information from the Army Corps or the state. Carl Georgeson Comments from the public regarding the historical significance of the Suicide prevention barrier and ways to save for its historical significance (first of its kind) mentioned that there is a plaque to Monica Dickens on the Canal overlook on the Scenic Highway. She was instrumental in having suicide barriers installed on the Bourne and Sagamore Bridges in the 1980s. John York proposed that the Historical Commission express support for installation of suicide barriers on the new replacement bridges.
- * Demolition Delay Order 9 Sandwich Road, Bourne Expired May 10, 2023 (Bourne Historical Society) nothing new.
- * Demolition Delay Order 6 MacArthur Boulevard, Bourne For 8 months to expire September 26, 2023 nothing new (CPA Funding approved STM May 2023 Article 4) The VFW is having problems getting a contractor to move the Information Booth. Cumberland Farms, owner of the property, has extended the time limit.

- * Carl Georgeson said that the possible repairs to the Bourne Library, formerly the Bourne Grammar School have raised a question. On MACRIS there are conflicting statements. In one place it says that the school is eligible for National Register. In another it states, "Because of the extent of the changes made to the interior, it is the opinion of Massachusetts Historical Commission staff that the Bourne Grammar School is not individually eligible for listing in the National Register of Historic Places." Carl offered to write the MHC to request they revisit their earlier opinion.
- * Carl Georgeson is working on the Commission's Annual Report for the Town Report July 1, 2022 June 30, 2023.

- * Next Demolition Delay Meeting Scheduled for October 24, 2023 96 Megansett Rd Cataumet

- * Future Agenda Items Steven Philbrick discussed the upcoming 100th anniversary of the establishment of the Bourne Fire Department, and that Pocasset Station and the Monument Beach Station would be up for demolition once the new station is built. Under the current proposal the Pocasset Station (built 1946) would have to be demolished or moved. The Monument Beach station, originally a carriage house for the Gardner Estate, was built in the 1890's and was converted to a fire station in the 1920's. It has a lot of historic significance for the town and the village. John York discussed some ideas for repurposing and saving this building for future town use. We also mentioned how it has been a center of community activities for many years. I mentioned that I agree it should be salvaged due to these factors and I would advise as the situation with the new station develops.
