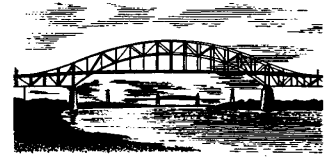

General Information

Seasonal Slip/Mooring Contracts will be accepted and be valid only if the following requirements are met:

1. This form is filled out completely, **including** current Registration & Documentation numbers, and returned with payment.
2. **Copies** of current Registration or Documentation and Hull & Liability Insurance **must be attached**.
3. **All** municipal assessments, betterments, fees, taxes, or any other charges, including previous Marina bills, **must be paid in full**.
4. Payments for the **2021 Season must be received in full** within the time frame noted on the bill, or otherwise upon demand.

Notice

Slip rates are based on slip minimum or length overall (LOA), whichever is greater. LOA is calculated including bowsprits, swim platforms, anchor roller protrusions, outboard motors, etc.; meaning the maximum length of the entire vessel and accessories. All vessels will be measured to confirm LOA and confirm correct slip fee billing. Boat owners who had a slip/mooring for the 2020 season will be given first consideration until due date noted on bill. All slips/mooring will be issued on an availability basis. The Management reserves the right to refuse any applications, reassign slips/mooring, limit duration, or make other stipulations, as deemed necessary. Slips/mooring are non-transferable and payments are non-refundable. Please read the general Marina Rules and Regulations, included with and made a part of this document, before signing this contract. Keep the Rules and Regulations in your possession for future reference. Any other conditions or changes that you are under obligation to follow will be posted at the Marina office. All boats must be removed from the Marinas by November 1st, or an additional fee of \$25 per day will be charged.
