IT IS THE RESPONSIBILITY OF THE INDIVIDUAL TO PERIODICALLY INSPECT ALL CHAFING GEAR ON THE MOORING PENNANTS TO ENSURE PROTECTION THROUGHOUT THE SEASON. THE TOWN OF BOURNE WILL NOT BE RESPONSIBLE FOR THE VESSEL GOING ADRIFT, AGROUND, OR DAMAGING ANOTHER VESSEL OR PROPERTY.
