

SPECIAL TOWN MEETING

<u>ARTICLE 1:</u> To see if the Town will vote to appropriate a sum of money for the purpose of the payment of **unpaid bills** from a previous fiscal year that are legally unenforceable due to the insufficiency of appropriation or take any other in relation thereto.

Sponsor – Board of Selectmen

ARTICLE 2: To see if the Town will vote to appropriate, borrow or transfer from available funds the sum of \$180,088 for the purpose of supplementing and/or reducing the FY2021 Regular Annual Expenses of the departmental expenses as voted under Article 2 (Fiscal Year 2021 Budget) of the 2020 Annual Town Meeting, or take any other action in relation thereto. Sponsor – Board of Selectmen

<u>ARTICLE 3:</u> To see if the Town will vote to appropriate, borrow or transfer from available funds, a sum of money for the purpose of funding the Town's **Other Post-Employment**Benefits (OPEB) Liability, or take any other action in relation thereto.

Sponsor – Board of Selectmen

<u>ARTICLE 4:</u> To see if the Town will vote to appropriate, borrow or transfer from available funds the sum of \$135,000 for the purpose of supplementing and/or reducing the FY 2021 Sewer Department Budget as voted under Article 3 (Sewer Department) of the 2020 Annual Town Meeting, or take any other action in relation thereto.

Sponsor - Board of Sewer Commissioners

<u>ARTICLE 5:</u> To see if the Town will vote to appropriate, borrow or transfer from available funds the sum of \$2,800,619 for the purpose of supplementing and/or reducing the FY 2021 ISWM Department Expense Budget as voted under Article 4 (ISWM) of the 2020 Annual Town Meeting, or take any other action in relation thereto.

ARTICLE 6: To see if the Town will vote to transfer from available funds from the Integrated Solid Waste Management (ISWM) Enterprise Fund retained earnings, a sum of money for the purpose of funding development, installation and operational costs associated with a Pilot Leachate Treatment System to be installed at the ISWM Facility, or take any action in relation thereto.
