Bourne Wetland Regulations
Part I Procedures and Regulations for all Wetlands

BWR 1.01 Introduction and Purpose

(1) Introduction. The Bourne Wetland Regulations, BWR 1.00, is promulgated by the Bourne Conservation Commission pursuant to the authority granted to them under the Bourne Wetlands By-law, Article 3.7 of the Town of Bourne By-laws. The BWR 1.00 shall complement Article 3.7 of the Town of Bourne By-laws, and shall have the force of law upon their effective date.

BWR 1.01 through 1.15 provide definitions and procedures. BWR 1.01 through 1.16 pertains to both inland and coastal areas subject to protection under Article 3.7 of the Town of Bourne By-laws. BWR 1.16 provides standards for work within those areas. A project may be subject to regulation under Article 3.7 of the Town of Bourne By-laws in which case compliance with all applicable regulations is required.

(2) Purpose. Section 3.7 of the Town of Bourne By-laws sets forth a public review and decision-making process by which activities affecting Areas Subject to Protection Under Article 3.7 of the Town of Bourne By-laws are to be regulated in order to protect the following wetland resource values:

- public and private water supplies
- groundwater supplies
- flood control
- erosion and sedimentation control
- storm damage prevention
- pollution prevention
- fisheries and shellfisheries
- wildlife habitat
- recreation and/or commercial use

The purpose of BWR 1.00 is to define and clarify that process by establishing standard definitions and uniform procedures by which the Commission may carry out its responsibilities under Article 3.7 of the Town of Bourne By-laws.

BWR 1.00 is intended solely for use in administering Article 3.7 of the Town of Bourne By-laws; nothing contained herein should be construed as preempting or precluding more stringent protection of wetlands or other natural resource areas by other by-laws, ordinance or regulations.

BWR 1.02 Area of Jurisdiction (Resource Areas)

(1) Areas Subject to Protection Under Article 3.7 of the Town of Bourne By-laws. The following areas are subject to protection under Article 3.7 of the Town of Bourne By-laws:

(a) Any:

- 1.bank,
- 2.freshwater wetland,
- 3.coastal wetland,
- 4.beach,
- 5.dune,
- 6.flat,
- 7.marsh,
- 8.swamp,
- 9.wet meadow, or
- 10.bog,

(b) Any:

- 1.creek
- 2.estuary,
- 3.stream,
- 4.pond, or

3 5. lake;
- 4 (c) the ocean;
- 5 (d) Land under water bodies;
- 6 (e) Riverfront Area;
- 7 (f) Land subject to flooding;
- 8 (g) Land subject to coastal storm flowage, but not including that portion of a A- zone greater than 100 feet from the areas
- 9 listed in BWR 1.02(1)(a) through (f)
- 10 (h) Land within 100 feet of the areas listed in BWR 1.02(1)(a) through (f).
- 11 (i) Land within 200 feet of the areas listed in BWR 1.02(1)(a) through (f) when in an ACEC or the BEOD.

14 (2) Activities subject to regulation under the By-law

15 (a) Activities within resource areas: any activity proposed or undertaken within an area specified in BWR 1.02(1) which,

16 in the judgment of the Commission, will remove, fill, dredge, alter or cause adverse effect to an area subject to protection

17 under the By-law is subject to regulation under the By-law and requires the filing of a Notice of Intent. If the applicant is

18 in doubt as to whether a Notice of Intent shall be required by the Commission, a Request for a Determination of Applicability

19 should be filed (BWR 1.05(4)(a)).

20 (b) Activities Outside the Areas Subject to Protection Under Article 3.7 of the Town of Bourne By-laws. Any activity

21 proposed or undertaken outside the areas specified in BWR 10.02(1) is not subject to regulation under Article 3.7 of the

22 Town of Bourne By-laws, and does not require the filing of a Notice of Intent unless and until that activity actually alters

23 an Area Subject to Protection Under Article 3.7 of the Town of Bourne By-laws referenced in BWR 1.02(1)(a) through (i).

24

25 In the event that the Commission determines that such activity has in fact altered an Area Subject to Protection Under Article

26 3.7 of the Town of Bourne By-laws referenced in BWR 1.02(1)(a) through (h), it shall impose such conditions on the activity

27 or any portion thereof as it deems necessary to contribute to the protection of the wetland resource values identified in Article

28 3.7 of the Town of Bourne By-laws.

29

30 (3) Not with standing the provisions of BWR1.02 (1) and (2), any fresh water wetland, bank, land under waterbodies, land subject

31 to flooding created for the purpose of stormwater management pursuant to Article 3.7 of the Town of Bourne By-laws, shall not

32 require the filing of a Notice of Intent or a request for Determination of Applicability to maintain the stormwater management

33 system, provided that the work is limited to the maintenance of the stormwater management system and conforms to a Permit

34 issued after August 31, 2000, and that the area is not altered for other purposes.

37 BWR 1.03 General Provisions

38

39 (1) Burden of Proof.

40 Any person who files a Notice of Intent to perform any work within an Area Subject to Protection Under Article 3.7 of the Town

41 of Bourne By-laws has the burden of demonstrating to the Commission:

- 42 (a) that the area does not play a role in the protection of any of the wetland resource values identified in Article 3.7 of the
- 43 Town of Bourne By-laws: or
- 44 (b) that the proposed work will contribute to the protection of the wetland resource values identified in Article 3.7 of the
- 45 Town of Bourne By-laws by complying with the general performance standards established in the By-law or BWR1.00 for
- 46 that area or activity.
- 47

48 (2) Burden of Production. The burden of production means having to produce at least some credible evidence from a competent

49 source in support of the position taken.

50

51 (3) Where any section of BWR 1.00 provides that a proposed project "may be permitted" in certain circumstances, no such project

52 shall be undertaken until all of the usual procedures required by Article 3.7 of the Town of Bourne By-laws and BWR1.00 have

53 been followed and a Permit has been issued for the work. The Commission shall impose such conditions on such projects as may

54 be necessary to contribute to the protection of the wetland resource values of Article 3.7 of the Town of Bourne By-laws.

DEFINITIONS

2
3 A-Zone (including A-, AE-, AI-30, & A99) means those portions of Land Subject to Coastal Storm Flowage which are subject
4 to inundation by types of 100 year flooding where stillwater flooding predominates. The landward boundary of the A-zone within
5 Land Subject to Coastal Storm Flowage shall be determined by reference to base flood elevation on the most recently available
6 flood data prepared for the Town of Bourne under the National Flood Insurance Program. The boundaries determined by the base
7 flood elevation and a topographical plan of the parcel performed by a registered engineer or other professional competent in such
8 matters and shall be presumed accurate.

9
10 ACEC means an Area of Critical Environmental Concern established pursuant to 301 CMR 12.00

11
12 Adjoining Land Areas means the land 100-ft. back as measured horizontally from the boundary of any Wetland Resource Area
13 not in an area designated by the Commonwealth of Massachusetts as an Area of Critical Environmental Concern (ACEC) or the
14 Bourne Environmental Overlay District (BEOD). In the ACEC and/or the BEOD, "Adjoining Land Areas" shall mean the
15 land 200-ft. back as measured horizontally from the boundary of any Wetland Resource Area. This area is hereafter referred
16 to as the Buffer Zone.

17
18 Adverse Effect means any change in the quality of a Wetland Resource Area that causes a diminishment in its ability to provide
19 the Wetland Resource Values protected by the By-law.

20
21 Alter means to change the condition of any Area Subject to Protection under the By-law. Examples of alterations include, but
22 are not limited to, the following:

- 23 (a) removal, excavation or dredging of soil, sand, gravel, or aggregate materials of any kind;
- 24 (b) changing of preexisting drainage characteristics, flushing characteristics, salinity distribution, sedimentation patterns,
25 flow patterns, or flood retention characteristics;
- 26 (c) drainage or other disturbance of water level or water table;
- 27 (d) dumping, discharging or filling with any material which may degrade water quality;
- 28 (e) placing of fill, or removal of material, which would alter elevations;
- 29 (f) driving of piles, erection or repair of buildings, or structures of any kind;
- 30 (g) placing of obstructions or objects in water;
- 31 (h) destruction of plant life, including cutting of trees;
- 32 (i) changing temperature, biochemical oxygen demand, or other physical or chemical characteristics of water;
- 33 (j) any activities, changes or work which may cause or tend to contribute to pollution of any body of water or groundwater;
34 or
- 35 (k) application of pesticides or herbicides.

36
37 Applicant means any person who files a request for determination of applicability or Notice of Intent, or on whose behalf such
38 a request or application is filed.

39
40 Area Subject to Protection Under the By-law means any area specified in BWR 1.02(1)

41
42 BEOD means the Bourne Environmental Overlay District

43
44 Bank (coastal) is defined in 310 CMR 10.30

45
46 Bank (inland) is defined in 310 CMR 10.54

47
48 Beach (coastal) is defined in 310 CMR 10.27(2)

49
50 Bog is a type of freshwater wetland.

51
52 Boundary means the boundary of a resource area.

53
54 Bourne Environmental Overlay District means that certain tract of land within the Town of Bourne that is bounded by the
55 Plymouth/Bourne town line, Route 3, the Cape Cod Canal and Route 25.

3 By-law means Article 3.7 Wetland and Natural Resource Protection By-law of the Town of Bourne.

4
5 Certificate of Compliance means a written determination by the Commission that work or a portion thereof has been completed
6 in accordance with a Permit.

7
8 Coastal Wetlands means any marsh, swamp, meadow, bank, flat or other lowland subject to tidal action.

9
10 Commission means the Conservation Commission of the Town of Bourne.

11
12 Compliance -A project is in compliance with these regulations and a Certificate of Compliance will be issued when the
13 Requirements set forth in BWR 1.05 (11) have been fulfilled (i.e., project is consistent with plans submitted and Permit issued).

14
15 Conditions means those requirements set forth in a written Permit issued by the Commission for the purpose of permitting,
16 regulating or prohibiting any activity that remove, fill, dredge, alter or cause adverse effect to an Area Subject to Protection
17 Under the By-law. [See also BWR 1.05(7).]

18
19 Conservation Commission Agent means the duly authorized representative of the Commission, with the authority to carryout
20 certain of the Commission's functions. These shall include, but not be limited to, carrying out site visits, determination of
21 application completeness, the issuance of Cease and Desist Orders, and reports to the Commission.

22
23 Creek means the same as a stream, as defined in BWR 1.04.

24
25 Date of Issuance means the date a Permit is mailed, as evidenced by a postmark, or the date it is hand delivered, as evidenced
26 by a signed receipt.

27
28 Determination.

29 (a) a Determination of Applicability means a written finding by the Commission as to whether a site or the workproposed
30 thereon is subject to the jurisdiction of Article 3.7 of the Town of Bourne By-laws.

31 (b) a Determination of Significance means a written finding by the Commission, after a public hearing, that the area on
32 which the proposed work is to be done, or which the proposed work will alter, is significant to one or more of the wetland
33 resource values identified in Article 3.7 of the Town of Bourne By-laws. It shall be made as part of the Permit.

34 (c) a Notification of Non-Significance means a written finding by the Commission, after a public hearing, that the area
35 on which the proposed work is to be done, or which the proposed work will alter, will not have a significant or cumulative
36 effect on any of the wetland resource values of Article 3.7 of the Town of Bourne By-laws.

37
38 Dinghy shall be defined by Section 15.0 of the Town of Bourne "Waterway Rules and Regulations"

39
40 Dune means coastal dune, as defined in 310 CMR 10.28(2).

41
42 Eelgrass Beds means those areas where the marine substrate is populated by eelgrass (*Zostera marina*) in quantities considered
43 significant to shellfish habitat as determined by DMF and/or Bourne DNR. Destruction of such beds is prohibited.

44
45 Erosion means the wearing away of the land by running water, wind, ice, or other geological agents.

46
47 Erosion and Sedimentation Control means both the ability of the Wetland Resource Area to perform these functions and the
48 responsibility of the project applicant to propose a design that incorporates these controls into the plan to prevent damage to
49 the wetland resource area, buffer zone or abutting properties from erosion/sedimentation and water displacement caused by
50 the project. Furthermore, each proposed project must be designed to prevent damage to the wetland resource area due to
51 scouring, propeller wash/shear, re-suspension of sediments and from increased wave energy. Projects shall be designed to cause
52 no adverse effect on significant shellfish habitat and/or eelgrass beds.

53
54 Extension Permit means a written extension of time within which the authorized work shall be completed.

55
56 FEMA means the Federal Emergency Management Agency.

57
58 Fill means to deposit any material so as to raise an elevation, either temporarily or permanently.

2
3 FIRM means the most recent Federal Insurance Rate Map of the Town of Bourne.

4
5 Fisheries and Shellfisheries means all fish and shellfish found in fresh, salt or brackish waters and any organisms (including
6 plants) that make up part of the food chain/web of such animals regardless of their commercial value. The By-law requires
7 that a project be designed so as not to contaminate, damage or impair fish/shellfish, its food supply, habitat, or water supply.
8 All projects proposed in public wetland resource areas must meet the performance standard of no adverse effect.

9
10 Flat is defined in 310 CMR 10.27(2)(b).

11
12 Flood Control means the ability of the Wetland Resource Area to prevent and/or reduce flooding and flood damage.

13
14 Freshwater wetland means a Wetland Resource Area that due to its vegetation, soils, and/or hydrology has at least one of the
15 following characteristics:

- 16 a. a wetland plant community,
17 b. holds enough water to provide a breeding habitat for certain water dependent fauna species, or
18 c. 50% or more of the vegetational community is composed of wetland plant species.

19
20 General Performance Standards means those requirements established by BWR 1.00 for activities in or affecting each of the
21 Areas Subject to Protection Under the By-law, Article 3.7 of the Town of Bourne By-laws.

22
23 Groundwater Supplies means any water below the earth's surface in the zone of saturation below the Wetland Resource Area
24 or below the Buffer Zone.

25
26 Hardship means the application of Article 3.7 of the Town of Bourne By-laws to a particular piece of property, evaluated in its
27 totality, owing to the unique characteristics of the property, that is unduly oppressive, arbitrary or confiscatory and would
28 involve substantial economic loss to the applicant because of the literal enforcement of the By-law provided that the conditions
29 and characteristics of the property are not the result of the actions of the applicant, or owner, or their agents, predecessors,
30 successors or assignees.

31
32 Impair means to make or cause to become worse; weaken or damage.

33
34 Isolated Land Subject to Flooding is defined in 310 CMR 10.57(2)(b).

35
36 Lake means any open body of fresh water with a surface area of ten acres or more, and shall include great ponds.

37
38 Land Containing Shellfish is defined in 310 CMR 10.34(2)

39
40 Land Subject to Coastal Storm Flowage is defined in 310 CMR 10.04

41
42 Land Subject to Flooding is defined in 310 CMR 10.57(2).

43
44 Land Subject to Tidal Action means land subject to the periodic rise and fall of a coastal water body, including spring tides.

45
46 Land Under Salt Ponds is defined in 310 CMR 10.33(2).

47
48 Land Under Water bodies and Waterways is defined in 310 CMR 10.56(2)

49
50 Limit of Work means the boundary beyond which no work may take place.

51
52 Marsh is a type of freshwater wetland.

53
54 Mean High Water Line means the line where the arithmetic mean of the high water heights observed over a specific 19-year
55 metonic cycle (the National Tidal Datum Epoch) meets the shore and shall be determined using hydrographic survey data of
56 the National Ocean Survey of the U. S. Department of Commerce.

3 Mean Low Water Line means the line where the arithmetic mean of the low water heights observed over a specific 19-year
4 metonic cycle (the National Tidal Datum Epoch) meets the shore and shall be determined using hydrographic survey data of
5 the National Ocean Survey of the U. S. Department of Commerce.

6

7 Minimize means to achieve the least amount of adverse effect that can be attained using best available measures or best
8 practical measures, whichever is referred to in the pertinent section.

9

10 Modify means to amend.

11

12 Ocean means Buzzards Bay, Massachusetts Bay and all contiguous waters subject to tidal action except salt ponds.

13

14 Notice of Intent means an application for a permit to remove, fill, dredge, alter or cause adverse effect an area subject to
15 protection under the By-law.

16

17 Person means any individual, group of individuals, association, partnership, corporation, company, business organization,
18 trust, estate, the Commonwealth or political subdivision thereof to the extent subject to town By-laws, administrative
19 agency, public or quasi-public corporation or body, Town of Bourne, or any other legal entity or its legal representative s,
20 agents or assigns.

21

22 Plans means such data, maps, engineering drawings, calculations, specifications, schedules and other materials, if any,
23 deemed necessary by the Commission to describe the site and/or the work, to determine the applicability of Article 3.7 of
24 the Town of Bourne By-laws, or to determine the impact of the proposed work upon the wetland resource values identified
25 in Article 3.7 of the Town of Bourne By-laws.

26

27 Pollution Prevention means a project must be designed in a manner as to not cause pollution to the ground or surface
28 waters and that will not in any way result in the degradation to the Wetland Resource Area.

29

30 Pond (coastal) - means Salt Pond as defined in 310 CMR 10.33(2)

31

32 Pond (inland) is defined in 310 CMR 10.04

33

34 Public and Private Water Supplies means any surface water or ground water supply that has, is, or could be used for consumption
35 by humans or livestock.

36

37 Recreational and/or Commercial Use means, but is not limited to, the purposes for which the Wetland Resource Area are used
38 by the public such as navigation, fishing, hunting, shell fishing, swimming, water skiing, diving, walking, etc. A project must be
39 designed so as to not impair the ability of the Wetland Resource Area to provide for these public recreational and/or
40 commercial uses.

41

42 Remove means to take away any type of material, thereby changing an elevation, either temporarily or permanently.

43

44 Request for Determination of Applicability means a written request made by any person to the Commission for a determination
45 as to whether a site or work thereon is subject to Article 3.7 of the Town of Bourne By-laws.

46

47 Riverfront Area is defined in 310 CMR 10.58

48

49 Rocky Intertidal Shore is defined in 310 CMR 10.31(2)

50

51 Salt Pond is defined in 310 CMR 10.32(2).

52

53 Significant Shellfish Habitat means those areas containing shellfish in densities (numbers) and/or habitat considered significant
54 By the state Division of Marine Fisheries (DMF) and/or the Bourne Department of Natural Resources (DNR). The Commission
55 Shall also evaluate information provided by local recreational and commercial shell fishers and by the applicant. No project shall

3 be permitted if it will cause any adverse effect on shellfish habitat and/or shellfish densities and/or impair the ability to harvest
4 shellfish and/or cause adverse effect to eelgrass beds.

5
6 Storm Damage Prevention means the project must be designed in a manner that ensures the prevention of damage to the Wetland
7 Resource Area and abutting properties caused by, but not limited to, erosion and sedimentation, damage to vegetation, damage
8 to property or buildings, or damage caused by the displacement of water, water-borne debris or water-borne ice.

9
10 Stream means a body of running water, including brooks, creeks, and rivers which moves in a definite channel in the ground
11 due to a hydraulic gradient, and which flows within, into or out of an Area Subject to Protection Under Article 3.7 of the Town
12 of Bourne By-laws. A portion of a stream may flow through a culvert or beneath a bridge. Such a body of running water which
13 does not flow throughout the year (i.e., which is intermittent) is a stream except for that portion up gradient of all freshwater
14 wetlands, bogs, swamps, wet meadows and marshes.

15
16 Swamp is a type of freshwater wetland.

17
18 V-zone means velocity zone.

19
20 VelocityZone (includingV-, VE-, & Vi-30) means those portions of Land Subject to Coastal Storm Flowage which are coastal
21 high hazard areas or areas of special flood hazard extending from the inland limit within the 100 year floodplain seaward
22 supporting waves greater than three feet in height. . The boundaries of the V-zones within Land Subject to Coastal Storm
23 Flowage shall be determined by reference to the most recently available flood data prepared for the Town of Bourne under the
24 National Flood Insurance Program. In the event of a v-zone boundary conflict, the Commission may require the applicant to
25 determine the boundary by engineering calculations which shall be based upon the appropriate wave height or wave run-up
26 methodology for the affected shoreline reach as set forth in the FEMA Publication, "Guidelines and Specifications for Wave
27 Envelope Determination and V-Zone Mapping," (the Guidelines), and prepared and certified by a registered professional
28 engineer. Notwithstanding the v-zone delineation on the most recent Federal Insurance Rate Map (FIRM), where a V-zone has
29 been depicted on the latest FIRM on a barrier beach with a frontal dune reservoir less than 540 square feet (as explained in the
30 National Flood Insurance Program and Related Regulations [44 Code of Federal Regulations, Chapter1, Section65.11]), the
31 V-zone shall be remapped using the Guidelines. (see illustration)

32
33
34 Vernal Pool means those areas mapped and certified by the Massachusetts Natural Heritage and Endangered Species Program
35 as well as those areas identified in the field as eligible for certification.

36
37 Water means all surface and ground water associated with the Wetland Resource Areas and/or the land 100-ft. from such areas.

38
39 Wet Meadow is a type of freshwater wetland.

The notice shall specify the date, time and location of the Commission meeting, and shall also specify where a copy of the Request for Determination, accompanying plans and documents may be examined and obtained.

(b) Determination of Applicability.

1. Within 21 days after the date of receipt of the Request for a Determination of Applicability, the Commission shall issue a Determination of Applicability. Notice of the time and place of the public hearing at which the determination will be made shall be given by the Commission at the expense of the person making the request not less than five days prior to such meeting, by publication in a paper of local circulation and by mailing a notice to the person making the request, and the owner. Notice shall also be given in accordance with the Open Meeting Law, M.G.L. c. 39, § 23B. Said determination shall be signed by a majority of the conservation commission, and copies thereof shall be sent by the Commission to the person making the request, and to the owner. Said determination shall be valid for three years from the date of issuance.

2. The conservation commission shall find that Article 3.7 of the Town of Bourne By-laws, applies to the land, or a portion thereof, if it is an Area Subject to Protection Under Article 3.7 of the Town of Bourne By-laws, as defined in BWR 1.02(1). The conservation commission shall find that Article 3.7 of the Town of Bourne By-laws applies to the work, or portion thereof, if it is an Activity Subject to Regulation Under Article 3.7 of the Town of Bourne By-laws as defined in BWR 1.02(2).

5. A Notice of Intent which is filed as a result of a positive determination shall be filed with the Commission, and all of the procedures set forth in BWR 1.05(5) shall apply.

(5) Notice of Intent

(a) Any person who proposes to do work that will remove, fill, dredge, alter or cause adverse effect to an Area Subject to Protection Under Article 3.7 of the Town of Bourne By-laws shall submit a Notice of Intent, and other application materials in accordance with the submittal requirements of 310 CMR 10.00, the By-law, and BWR 1.00.

1. The person filing a Notice of Intent with the Bourne Conservation Commission must submit with said document a Notice of Intention Authorization Form which clearly identifies the locus of the intended project, certifies to the Commission that the applicant is the owner of the locus where work is to occur and that the owner approves of the proposed work.

(b) A Notice of Intent shall expire where the applicant has failed to diligently pursue the issuance of a Permit in proceedings under BWR 1.00. A Notice of Intent shall be presumed to have expired one year after the date of filing unless the applicant submits information showing that (a) good cause exists for the delay of proceedings under BWR 1.00; and (b) the applicant has continued to pursue the project diligently in other forums in the intervening period; provided, however, that unfavorable financial circumstances shall not constitute good cause for delay. No Notice of Intent shall be deemed expired under this section when an appeal is pending and when the applicant has provided all information necessary to continue with the prosecution of the case.

(c) Compliance with Section 3.112 of the Town of Bourne By-laws. At the time of filing the Notice of Intent, the owner(s) of the property(ies) upon which the project is proposed that they are in compliance with Section 3.11.2 regarding payment of any local taxes, fees, assessments, betterments or other municipal charges, including amounts assessed under the provisions of section 21D.

(d) reserved

(e) Abutter Notification for Notice of Intent Any person filing a Notice of Intent with the conservation commission shall at the same time give written notification thereof, by delivery in hand, or certified mail, return receipt requested, to all abutters and other land owners within 100 feet of the property line of the land where the activity is proposed, at the mailing addresses shown on the most recent applicable tax list of the assessors, including, but not limited to, owners of land directly opposite said proposed activity on any public or private way, and in an other municipality or across a body of water. Said notification shall be at the applicants expense, and shall state where the copies of the Notice of Intent may be examined and obtained or shall include a copy of the complete Notice of Intent and where information the date, time and place of the hearing may be obtained. An affidavit of the person providing such notice, with a copy of the notice mailed or delivered, shall be filed with the Commission.

3 (6) Public Hearings.

4 (a) A public hearing shall be held by the Commission within 21 days of receipt of the minimum submittal requirements
5 and shall be advertised in accordance with Article 3.7 of the Town of Bourne By-laws and the requirements of the Open
6 Meeting Law, M.G.L. c. 39, § 23B.

7 (b) The advertising cost for a public hearing for a permit or request for determination shall be paid by the applicant. The
8 advertising cost for a public hearing for any other matter shall be paid by the person requesting said hearing.

9 (c) Public hearings may be continued as follows:

10 1. without the consent of the applicant to a date announced at the hearing, within 21 days, of receipt of the complete
11 Notice of Intent;

17 (7) Permits

18 (a) Scope. A Permit is designed to allow the proposed construction activity while, at the same time, ensuring that valuable
19 wetlands resources will be protected from either deliberate or accidental damage. Resource area protection is achieved
20 by a combination of design elements within the approved plan and by additional conditions imposed by the Commission.
21 All construction activities must be completed in compliance with the existing Permit.

22 (b) Within 21 days of the close of the public hearing, the Commission shall either:

23 1. make a determination that the area on which the work is proposed to be done, or which the proposed work will
24 remove, fill, dredge, alter or cause adverse effect to, is not significant to any of the wetland resource values identified
25 in Article 3.7 of the Town of Bourne By-laws, and shall so notify the applicant; or

26 2. make a determination that the area on which the work is proposed to be done, or which the proposed work will
27 remove, fill, dredge, alter or cause adverse effect to, is significant to one or more of the wetland resource values
28 identified in Article 3.7 of the Town of Bourne By-laws, and shall issue a Permit for the protection of said wetland
29 resource value(s).

30 (c) The Permit shall impose such conditions as are necessary to meet the performance standards set forth in 310 CMR
31 10.21 through 10.60 and BWR 1.16(1). The Permit shall impose conditions only upon work or the portion thereof that
32 is to be undertaken within an Area Subject to Protection Under the By-law. The Permit shall impose conditions setting
33 limits on the quantity and quality of discharge from a point source (both closed and open channel), when said limits are
34 necessary to protect the wetland resource values identified in the By-law; provided, however, that the point of discharge
35 falls within an Area Subject to Protection Under the By-law.
36

37 Notwithstanding the foregoing, when the Commission has determined that an activity outside the Areas Subject to Protection
38 Under the By-law has in fact altered an Area Subject to Protection Under the By-law, it shall impose such conditions on any
39 portion of the activity as are necessary to contribute to the protection of the wetland resource values identified in the By-law.
40

41 (d) Except as provided in M.G.L. c. 131, § 40 for maintenance dredging, a Permit shall be valid for three years from the
42 date of its issuance; provided, however, that the Commission may issue a Permit for up to five years where special
43 circumstances warrant and where those special circumstances are set forth in the Permit.

44 (e) The Permit shall be signed by a majority of the Commission and shall be mailed or hand delivered to the applicant or
45 his agent or attorney.

46 (f) A copy of the plans describing the work and the Permit shall be kept on file by the conservation commission and shall
47 be available to the public at reasonable hours.

48 (g) Prior to the commencement of any work permitted or required by the Permit, the Permit shall be recorded in the
49 Registry of Deeds or the Land Court for the district in which the land is located, within the chain of title of the affected
50 property. In the case of recorded land, the Permit shall also be noted in the Registry's Grantor Index under the name of the
51 owner of the land upon which the proposed work is to be done. In the case of registered land, the Permit shall also be noted
52 on the Land Court Certificate of Title of the owner of the land upon which the proposed work is to be done. Certification
53 of recording shall be sent to the Commission. If work is undertaken without the applicant first recording the Permit, the
54 Commission may issue an Enforcement Order or may itself record the Permit.

3 (8) Amended Permits

4 (a) Following the issuance of a Permit, unforeseen circumstances sometimes arise which may require minor deviations from
5 the project approved in that Permit. To allow for the smooth operation of the permitting procedure and to avoid unnecessary
6 and unproductive duplication of regulatory effort after a Permit has been issued, it would not be reasonable to require a
7 complete refile of the Notice of Intent when the changes sought in the Permit are relatively minor and will have unchanged
8 or less impact on the wetland resource values protected by the By-law. Amended Permits provide assurances to applicants
9 that modifications undertaken in the course of the project are within the scope of the deviations allowed for the receipt
10 of a Certificate of Compliance at BWR1.05(11). No Amended Permit shall be issued for a Permit that has expired.

11 (b) Minor Changes. The most simple changes, such as correcting obvious mistakes such as citing a wrong file number or
12 typographical errors, may be accomplished by correction of the Permit by the Commission or the Conservation Agent.

13 (c) Moderate Changes.

14 1. The applicant shall make a request for an amendment to the Commission. The request for an amendment of the
15 Permit is to be made either orally at a regularly scheduled meeting of the Commission or by submitting the request
16 to the Commission in writing.

17 2. The Commission shall make a determination whether the requested change is of a relatively minor nature and can
18 be considered as an amendment to the original Permit. In making this determination, the Commission shall consider
19 such factors as whether the purpose of the project has changed, whether the scope of the project has increased, whether
20 the project meets relevant performance standards, and whether the potential for adverse impacts to the protected
21 statutory wetland resource values will be increased. Relatively minor changes which result in the same or decreased
22 impact on the wetland resource values protected by the By-law shall be considered a Minor Change.

23 3. If the Commission determines that a new Notice of Intent is not necessary, the Commission shall publish newspaper
24 notice (at the applicant's expense) in the same general manner as outlined in the By-law for a new Notice of Intent and
25 as required by the Open Meeting Law, M.G.L.c.39, §23B, to inform the public that the request for amendment to the
26 Permit will be considered by the Commission at a public hearing.

27 4. The applicant shall follow the requirements of a butter notification as if filing a Notice of Intent as described in
28 BWR 1.05(5).

29 5. The usual appeal procedure of the Permit shall apply to the amended permit, however the issues under appeal will
30 be limited to those issues subject to the amendment(s) or the change(s) made in the Permit. Until there is a final
31 resolution of the appeal, no work may continue on those portions of the project not permitted under the Permit but
32 only permitted by the amendment(s) which has been appealed.

33 6. Under no circumstances shall the issuance of an Amended Permit extend the effective date of the original Permit.

34 The Amended Permit shall run with the term of the original Permit or the effective date of an extended Permit.

35 7. The Amended Permit shall be issued on the form provided for a Permit, with the insertion of the word "Amended"
36 and the amendment date. Amended Permits shall be recorded with the Registry of Deeds in the same manner as Permits.

37 (d) Significant Changes. Significant changes require the filing of a new Notice of Intent.

38

39 (9) Denials

40 (a) Procedural Denials.

41 If the Commission finds that the information submitted by the applicant is not sufficient to describe the site, the work, or
42 the effect of the work on the wetland resource values identified in the By-law, it may issue a denial prohibiting the work.

43 The denial shall specify the information which is lacking and why it is necessary. In writing the procedural denial, the
44 Commission shall:

45 1. State that the denial is specifically based on lack of information describing the site, the work and/or the effect of
46 the work on the wetland resource values identified in the By-law;

47 2. List specific information needed in each of the three possible problem areas mentioned above, citing appropriate
48 sections of BWR 1.00; and

49 3. State that the Commission encourages a resubmittal of a Notice of Intent with the above requested information.

50 (b) Substantive Denials. The Commission shall prohibit any work or any portion thereof that cannot be conditioned to meet
51 the standards of 310 CMR 10.00, BWR 1.16(1) and the By-law.

53 The written decision will include the reasons for the denial, citing wetland resource values protected, and relevant
54 regulations. The written decision will be signed by a majority of the Commission.

3 (10) Extensions of Permits.

4 (a) The Commission may extend a Permit for one or more periods of three years each. The request for an extension shall

7 work in the following circumstances:

8 1. where no work has begun on the project, except where such failure is due to an unavoidable delay, such as appeals,

17 1. Any party specified in BWR 1.10(1)(a) may request a hearing in writing prior to the issuance of the Extension
18 Permit, or within 10 days of the issuance of the decision relative to the request for an Extension Permit.

19 2. Any decision regarding an Extension Permit where no hearing was held shall be a tentative decision.

20 3. Where no hearing has been held, and no request for a hearing has been made pursuant to BWR 1.05(10)(c)1, the
21 tentative decision shall be final.

22 4. Where a request for a hearing is made, the commission shall conduct a hearing and issue a final decision pursuant
23 to the procedures specified in BWR 1.05(6).

24 5. Where a request for a hearing is filed after the tentative decision is issued, the Commission shall conduct a hearing
25 regarding the issuance of a final decision without prejudice to all parties.

26 (d) The Extension Permit shall be signed by a majority of the commission.

27 (e) The Final Extension Permit shall be recorded in the Land Court or the Registry of Deeds, whichever is appropriate.

28 Certification of recording shall be sent to the Commission. If work is undertaken without the applicant so recording the
29 Final Extension Permit, the Commission may issue an Enforcement Order or may itself record the Final Extension Permit.

31 (11) Certificate of Compliance

32 (a) Upon written request by the applicant for a Certificate of Compliance, the Commission shall issue a decision regarding
33 the request within 21 days of receipt thereof. A Certificate of Compliance is issued by the Commission and may certify
34 that the activity or portions thereof described in the Notice of Intent and plans has been completed in compliance with the
35 Permit. The Certificate of Compliance shall be signed by a majority of the Commission.

36 (b) Prior to the issuance of a Certificate of Compliance, a site inspection shall be made by the Commission, or its agent,

47 specify to what portions of the work it applies, if it does not apply to all the work regulated by the Permit.

48 (f) The Final Certificate of Compliance shall be recorded in the Land Court or Registry of Deeds, whichever is appropriate.
49 Certification of recording shall be sent to the Commission. Upon failure of the applicant to so record, the Commission
50 may do so.

51 (g) Request for Hearing

52 1. Any party specified in BWR 1.10(1)(a) may request a hearing in writing prior to the issuance of the Certificate of
53 Compliance, or within 10 days of the issuance of the decision relative to the request for a Certificate of Compliance.

54 2. Any decision regarding a Certificate of Compliance where no hearing was held shall be a tentative decision.

55 3. Where no hearing has been held, and no request for a hearing has been made pursuant to BWR 1.05(11)(g)1, the

16 (b) If the applicant fails to timely record any of these documents (unless in accordance with paragraph c, below), the
17 Commission is empowered to do so. As proof of recording, the applicant must deliver to the Commission the recording
18 slip at the bottom of the Permit, Amended Permit, Notification of Non-Significance, Final Extension Permit, or Final
19 Certificate of Compliance, as appropriate. In such cases, the Commission is also empowered to issue an Enforcement
20 Order prohibiting any work.

21 (c) If the applicant desires to delay the recording of the Permit, they shall so state in writing to the Commission the reasons
22 for the delay, and the estimated date of recording. In no case shall any construction commence unless and until the Permit
23 has been recorded.

44 (b) The following forms of security shall be executed and duly recorded in the Barnstable County Registry of Deeds by
45 the owner of record running with the land the benefit of the Town of Bourne whereby the applicable permits conditions
46 shall be performed and observed before any lot may be conveyed other than by mortgage deed:

- 47 1. conservation restriction pursuant to Sections 31, 32, and 33 of Chapter 184 of the General Laws;
48 2. easement; or
49 3. other covenant running with the land enforceable in a court of law

51 (3) The performance guarantee specified in BWR 1.07(2)(a) should be extended to "The Town of Bourne Conservation
52 Commission" based on the Permit, (File _____), Special Condition No. _____. and shall state the specific work covered by
53 the performance guarantee.

50 signed by a single member, agent of the Commission, or Natural Resource Officer, prior to a hearing, provided a hearing is
51 held at the soonest available time and said Order is ratified by a majority of the members after said hearing.

53 (3) Criminal Complaints filed pursuant to Chapter 1, section 1-1, of the Code of the Town of Bourne

54 (a) Section 3.7.6 of the By-laws of the Town of Bourne provides that: “ Any person violating this bylaw shall be punished
55 by a fine of not less than \$50.00 nor more than \$300.00 for each offense. Each day or portion thereof during which a
56 violation continues shall constitute a separate offense.”

9 Natural Resources Officers/The Harbormaster/ Shellfish Constable of their deputies, taking cognizance of a violation, of a
10 specific by-law rule or regulation which he or she is empowered to enforce, hereinafter referred to as the enforcing person(s),
11 as an alternative to initiating criminal proceedings, may give to the offender a written notice to appear before the Clerk of the
12 District Court having jurisdiction thereof at anytime during office hours, not later than twenty-one days after the date of such
13 notice. Such notice shall be in triplicate and shall contain the name and address, if known, of the offender, the specific offense
14 charged and the time and place for his/her required appearance. Such notice shall be signed by the enforcing person, and shall
15 be signed by the offender whenever practicable, in acknowledgement that such notice has been received. Any notice and
16 enforcement of violation shall be in accordance with the provisions of Massachusetts General Law, Chapter 40, Section 21D.

17 (b) Natural Resource Officers may issue citations to those violating the provisions of Section 3.7 of the By-laws of the
18 Town of Bourne pursuant to Section 6.1.2 of the By-laws of the Town of Bourne.

23 (1) Consultant Fee

24 (a) The Commission, at its discretion, is authorized to require the posting of a Consultant Fee by an applicant. This fee shall
25 be used to hire an independent, expert consultant to investigate the site for the proposed project and to examine the plans
26 or other information submitted by the applicant to assist the Commission in evaluating potential adverse impacts upon a
27 resource area by the proposed project. This fee will be required in those cases where the complexity of the activity, the
28 difficulty in determining the threat to the wetland resource values or the size of the request or project involves and requires
29 more information and analysis than can reasonably be supplied to the Commission without independent technical
30 professional assistance.

31 (b) The Commission may require the payment of the Consultant Fee at any time in the deliberations prior to a final decision.

32 (c) The Consultant Fee may be required for expert opinions regarding, but not limited to, wetland resource area surveys
33 and delineations, analysis of wetland resource area surveys and delineations, wetland resources area reports, hydrological
34 and drainage analysis, wildlife evaluation, shellfish surveys, and environmental/land use law.

35 (d) The commission is hereby authorized to charge for said consultant fee when the Notice of Intent or Request for
36 Determination of Applicability, proposes any of the following:

- 37 1. five hundred (500) square feet or greater alteration of a resource area specified in BWR 1.02(a);
- 38 2. fifty (50) linear feet or greater of bank alteration to a coastal or inland waterway;
- 39 3. five hundred (500) square feet or greater alteration to the buffer zone;
- 40 4. five hundred (500) square feet or greater alteration of land under a water body or the ocean;
- 41 5. discharge of any pollutants into or contributing to surface or groundwater or the wetland resource area or buffer zone;
- 42 or
- 43 6. construction of any stormwater control facility, or water control structure.

44 (e) Determination of Amount of Consultant Fee for a Notice of Intent

- 45 1. The maximum consultant fee charged to reimburse the commission for reasonable costs and expense shall be two
46 thousand five hundred dollars (\$2,500).

47 (f) The applicant shall pay the consultant fee to the Town to be put into a special purpose account established by the
48 Commission, which may be drawn upon by the Commission at one of its public meetings.

49 (g) The Commission shall return any unused portion of the consultant fee to the applicant.

50 (h) Any applicant aggrieved by the imposition of, or the amount of, the consultant fee, or any act related there to, may appeal
51 according to the provisions of the Massachusetts General Laws.

42 BWR 1.16 Specific Activities Regulated

43 Introduction- Under the By-law, activities in the following areas are subject to Conditions by the Commission. The complexity
44 of these activities warrants the specific requirements set forth below.

45 (1) Docks, Piers and Walkways

46 (a) Introduction. The construction, use, and maintenance of docks, piers and walkways are likely to have a significant or
47 cumulative adverse effect on the wetland resource values of storm damage prevention, fisheries and shell fisheries, wildlife
48 habitat, erosion and sediment control, and recreation and/or commercial uses. Construction, maintenance and use of piers
49 can have adverse effect on resource areas and navigation for recreational purposes. Further, piers destroyed by storm pose
50 a threat to nearby properties by increasing water borne debris.

51
52 Turbulence and propeller dredging generated by boat traffic significantly increase turbidity levels. High turbidity levels
53 attenuates light. Light is necessary for photosynthetic processes responsible for the primary productivity and oxygen
54 regeneration of the water. The suspended sediments settle on shellfish beds, smothering existing shellfish and altering the
55 quality of the sand bottom essential for spat (mollusk larvae) settlement. Resuspension of bottom sediments causes

3 redistribution of sediments, alteration in sediment grain size distribution and causes changes in bottom topography relief,
4 elevation and grade, including creation of depressions in the bottom. Resuspension of sediments into depressions creates
5 deep pockets of sediment which may not be able to physically support shellfish or which can become anoxic and therefore
6 not support shellfish. Resuspension of sediments during the period of shellfish larval settlement hinders or prevents the
7 effective settlement of shellfish larvae. Boat traffic generated from piers will add to this disruption and may cause erosion
8 of banks and marshes.

9

10 Construction of piers and subsequent boat activity causes resuspension of nutrient-laden sediment particles which may
11 cause a release of sediment-bound nutrients to the water column resulting in a "bloom" of vegetation. Release of nutrients
12 to the water column leads to eutrophication and anoxic bottom conditions. Anoxic sediments and anoxic bottom conditions
13 create adverse impacts on benthic resources, including shellfish and fisheries.

14

15 While pier construction is typically the least environmentally destructive method of crossing a marsh, it may adversely
16 affect the physical characteristics and functional value of a marsh. Marsh plants provide the major energy flow (detritus
17 food chain) between the autotrophic and heterotrophic levels in a marsh-estuarine system. Many species of sport and
18 commercial fish and shellfish are dependent upon this system. Plants adapted to high ambient light intensity, such as marsh
19 grasses, are ill-adapted to the shaded conditions created by a pier. Shading may result in the loss of vegetative biomass
20 (decreased plant height, population density, and leaf thickness) or alteration of species composition. Reductions in plant
21 density result in the loss of sediment normally trapped by roots and culms. Tidal washout of sediment could result in
22 localized depressions which, through evaporation of trapped water, concentrate salt. High sediment salt levels effectively
23 preclude recolonization by original vegetation. Localized tidal washout may lead to further vegetative regression, erosion,
24 and disruption of natural communities in the area.

25

26 Propeller turbulence near or in areas of submerged aquatic vegetation, such as eel grass, or salt marsh damages vegetation,
27 thereby increasing the rate at which organic detritus is produced. If this organic detritus does not completely decompose
28 aerobically, then anoxic bottom conditions will ensue, which adversely impact shellfish and fisheries.

29

30 Cumulative impacts of the construction, maintenance and use of piers threaten to decrease the overall productivity of the
31 marsh ecosystem, to reduce its ability to absorb storm wave energy, and to reduce its contribution to ground water and
32 surface water quality.

33

34 Docks and piers when placed in Land Containing Shellfish have an adverse impact on the resource area value of recreational
35 and/or commercial use. The placement length and size of the dock and the floats can interfere with the harvesting of
36 quahogs and scallops.

37

38 Piers, depending on their length, can have an adverse impact on recreation by interfering with recreational boating activities.
39 Not properly designed, piers can interfere with intertidal lateral access for recreational fishing and fowling. Any proposal
40 that affects navigation is likely to have a significant or cumulative adverse effect on recreation. Excessive lighting on piers
41 can cause temporary "night blindness" in boaters.

42

43 (b) Definitions:

44

45 Dinghy shall be defined by section 15.0 of the Town of Bourne " Waterway Rules and Regulations"

46

47 Dock means the entire structure of any pier, wharf, walkway, bulkhead, or float, and any part thereof including pilings,
48 ramps, walkways, float and/or tie-off pilings, that is located on a Bank (inland), 310 CMR 10.54, Land Under Water
49 Bodies and Waterway, 310 CMR 10.56, Land Under the Ocean, 310 CMR 10.25, Land Under a Salt Pond, 310 CMR
50 10.33, Rocky Intertidal Shore, 310 CMR 10.31, or that portion of a Coastal Beach (310 CMR 10.27) seaward of the
51 mean high water line. When a salt marsh (310 CMR 10.32) is below the mean high water line, the dock is that structure
52 seaward of the salt marsh. Notwithstanding the above, either a swimming float or work float, kept at a mooring, that
53 receives a permit from the Harbormaster, is not a float subject to regulation pursuant to the By-law.

54

55 Navigation means the ability to traverse a waterway.

3 Pier means the dock, walkway, wharf, bulkhead, piers, piles, ramp and floats.

4
5 Seasonal use means the dock, ramp, floats, and all supporting materials are not placed in any wetland resource area
6 prior to April 1, of each year and are removed prior to November 1, of each year.

7
8 Walkway means the entire structure of any pier, wharf, walkway, or bulkhead, and any part thereof including pilings,
9 or ramp, that is located on a Bordering Vegetated Wetlands, 310 CMR 10.55, Salt Marsh, 310 CMR 10.32, Dune,
10 310 CMR 10.25, or that portion of a Coastal Beach (310 CMR 10.27) landward of the mean high water line.

- 26 2. a description of the construction process, including the method for pile installation;

- 41 a. The plan must show how the location of each transect and quadrat used in the shellfish fisheries survey performed
42 pursuant to BWR 1.16(1)(b)7.b.. These should be numbered/lettered for easy reference and for field identification
43 purposes. A Shellfish/Fisheries Report based upon the findings and data collected pursuant to the Shellfish/Fisheries
44 Survey must be appended to the Notice of Intent.
- 45 b. Shellfish/Fisheries Survey Methodology
- 46 (i.) The survey must employ the standard Transect Quadrat sampling method. A representative number of
47 transects and quadrats must be used to adequately assess the standing shellfish crop. At least 0.5% of the
48 subject area must be sampled. However, no survey consisting of fewer than 10 quadrats will be considered
49 as sufficient information. Quadrats shall measure 1 foot square. The location of the quadrats shall be
50 selected in a random fashion.

*Pursuant to BWR 1.02(2), a Notice of Intent is required for any new pier, fixed or floating, permanent or seasonal. A Notice of Intent is also required for any change or repair which alters any dimension, shape or function of an existing pier.
