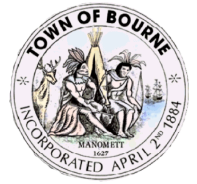

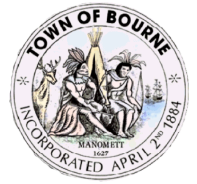
**6:00 PM EXECUTIVE SESSION** Chapter 30A, Section 21 mandates that in order to go into Executive Session the committee must:
