- 3. 26 Indian Trail J.E. Landers-Cauley on behalf of Owners Steven & Jean Cohen CONTINUED from Sept. 16, 2020-Requesting septic variances including a 2.8 foot reduction in the required 10 foot setback from the proposed leaching facility to the front property line and a 62.6 foot reduction from the 150 foot setback requirement from the proposed leaching facility to a coastal bank.
- 4. 455 Circuit Avenue Michael Pimentel of J.C Engineering on behalf of owners John & Nancy McCarthy- Modification of variances and waivers approved on August 12, 2020. Approve revised plans requesting multiple variances to State and local Board of Health regulations in order to install a septic system for a home located at 455 Circuit Ave. Variances requested include a 89.9 foot reduction in the required 150 foot setback from the S.A.S to the Coastal Bank #2. A 5 foot reduction in the required 10 foot setback from the septic tank to the northerly property line. A 5 foot reduction in the 10 foot required setback from the septic tank to the westerly property line. A 2.1 foot reduction from the required 20 foot setback from the S.A.S. to the house located at #451 Circuit Ave. A 1.9 foot reduction from the SAS to the home located on 455 Circuit Ave. A 6.7 foot reduction from the required 10 foot setback from the S.A.S. to the westerly property line and a 2.6 foot reduction from the required 10 setback from the SAS to the existing water line.
- 5. 22 Nye Lane- Zachary Basinski P.E. of Bracken Engineering on behalf of owners Nam P. Suh and Yung J. Suh Requesting relief from State and local Board of Health Regulations. Requested septic variances include a 125 foot reduction from the required 150 foot setback from a soil absorption system to a non-eroding coastal bank and a 90 reduction from the required 150 foot setback from a soil absorption system to a coastal beach.

Variances requested include a 88 foot reduction from the required 150 foot setback from a soil absorption system to the non-eroding coastal bank on the west side of the property, a 59 foot reduction from the required 150 foot setback from the soil absorption system to the non-eroding coastal bank on the east side of the property and a 30 reduction from the required 150 foot setback from the soil absorption system to a salt marsh
- 7. 85 Elgin Rd Kenneth Breivogal P.E. of Jack Landers-Cauley on behalf of owner Charles William Lowney Requesting relief from State and local Board of Health regulations. Variances requested include a 49.9 foot reduction from the required 150 foot setback from the soil absorption system to a coastal bank and a 25.9 foot reduction from the required 150 foot setback from the soil absorption system to a wetland.
