Minutes from the Board of Assessors Meeting which was held on January 28, 2020

Open Session Meeting called to order: at 9:07 am

The Board reviewed the minutes from the Open Session and Executive Session Meetings of the Board of Assessors, which was held on: November 15, 2019. A motion to approve and release the minutes was made by Priscilla Koleshis, seconded by Michael Leitzel and the vote was unanimous by roll call vote.

The Board reviewed applications for Chapter 61B land qualification for properties:

- A Notice of Intent to Sell, which has been submitted to the Town of Bourne, by the owners of 274 Williston Road (Assessors ID 7.0-48) property that is qualified as Chapter 61B Recreational & Open Space Land. The Board agreed that if the property is removed from Chapter 61B, roll back tax would be calculated and billed to the current owner.

Under M.G.L. c. 30A Sec. 21(a)(7) and to comply with M.G.L. Ch. 59, Sec. 60., a motion was made by Priscilla Koleshis, and seconded by Michael Leitzel, to go into Executive session to discuss tax abatement applications. The vote was unanimous by roll call vote.
